**Game of Chance Surety Bond  
General Indemnity Agreement**

SCA Insurance Specialists, Inc. ("SIS") is hereby appointed as Attorney-In-Fact for the sole purpose of registering and bonding on behalf of Indemnitor ("Sponsor"). This Agreement shall cover all current and future bonds obtained for Sponsor's promotions.

This Agreement is entered into between undersigned Sponsor and Platt River Insurance Company ("Surety") to execute and deliver Game of Chance bonds on behalf of Sponsor for the purpose of registering promotions with state governmental agencies.

The Sponsor agrees to indemnify the Surety and hold harmless the Surety from any and all liability, damages, loss, cost, expenses, including attorney's fees which the Surety may sustain or incur as a consequence of having executed said bond(s), provided such liability, damages, loss, cost, expenses do not arise from gross negligence on the part of Surety.

Sponsor agrees, in the event of a claim, to pay Surety, upon demand, a sum of money equal to any loss and expense reserve set up by Surety to cover any liability, claim, suit, judgement or cost against said bond(s), unless such claim is due to Surety's gross negligence as noted above.

Sponsor agrees any promotion for which a bond is issued under this Indemnity Agreement will be governed by promotion rules approved by SIS and that any promotion rules for any bonded promotion will be based on a defined winning trigger mechanism which must occur before liability may be assumed. Approval is for bonding purposes and is not a legal review.

Surety shall have exclusive right to determine whether any claim or suit shall, on the basis of liability, expediency or otherwise, be paid, compromised, defended or appealed.

Sponsor understands and agrees that Surety has the right in their sole discretion to decline to issue any current or future bond(s), for any reason.
