

**LIMITED POWER OF ATTORNEY**

**BE IT KNOWN**, that \_\_\_\_\_ (name of Client Representative) as the authorized representative of \_\_\_\_\_ (name of Client) has made and appointed, and by these presents does hereby for the term of this Limited Power of Attorney, irrevocably make and appoint John C. Still and/or Wendy S. Collins as representatives of SCA Promotions, Inc., SCA Insurance Specialists, Inc. c/o RegisterSweeps.com ("SCA") as lawful attorney(ies) for it and in its name, place and stead, for the following specific and limited purposes only:

- 1. To complete, execute, and file on behalf of Client, promotion registration documentation with appropriate state agencies in Florida, New York and Rhode Island (Obligee); where applicable, and when applicable; and
- 2. To complete, execute, and file on behalf of Client game of chance surety bonds and/or affidavits of request of waiver of surety bond/trust account with appropriate state agencies where and when applicable; and
- 3. To complete, execute, and file on behalf of Client winners list with appropriate state agencies where and when applicable.

Client understands and agrees that in completing, executing and filing materials on behalf of Client as per paragraphs 1-3 above, SCA is acting in express reliance on the accuracy and completeness of the statements, representation, information and data communicated by Client (or its representatives) to SCA regarding a given promotion.

Client agrees to indemnify any state and/or SCA for any claims that arise against that state and/or SCA due to the state's and/or SCA's reliance on this Limited Power of Attorney or the performance of its responsibilities as set forth in paragraphs 1-3 above, except only for those actions of the Obligee that were negligent or intentional.

This Limited Power of Attorney shall terminate and be of no further force or effect upon the 30<sup>th</sup> day after SCA's receipt from an authorized representative of Client's written notice of such termination. Upon the effective date of such termination, all of the responsibilities stated in paragraphs 1-3, above, shall fully revert to Client, and SCA shall be relieved of all of said responsibilities.

The Client representative warrants and represents that he/she is duly authorized to make this Limited Power of Attorney for and on behalf of Client.

The parties understand and agree that SCA is an independent contractor of Client.

This Limited Power of Attorney shall serve as a final and complete expression of the mutual agreement of the parties, and supersedes any and all prior and contemporaneous agreements and understandings relating to it.
